For over 5 hours, our lawyers provided free consultations on various aspects of life in the UK, including immigration, social, tax, educational, and employment issues.

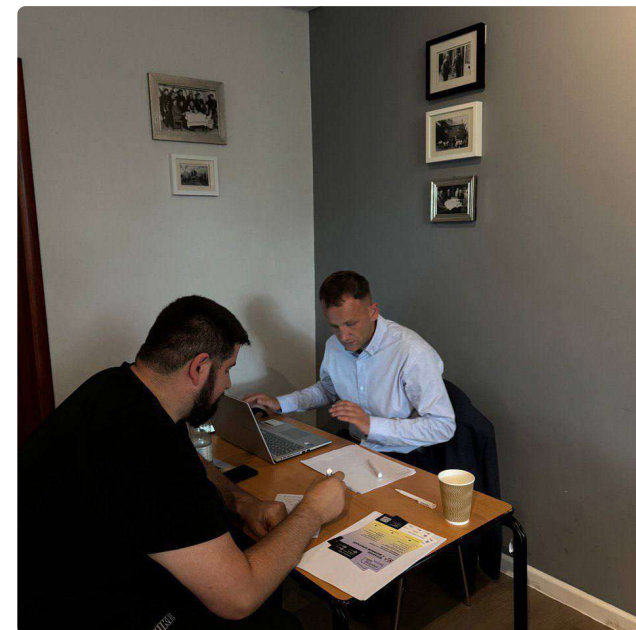
FIFTH UKRAINIAN CONFERENCE
